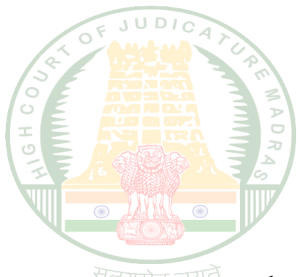

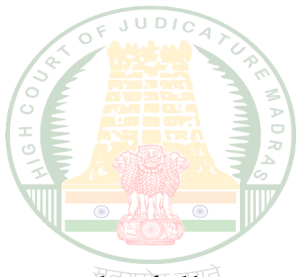
Prayer :-

Prayer in WP(MD).9453 of 2024 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records relating to the proceedings of the 1st respondent made in Na.Ka.No. 15818/Aa3/2023 dated 30.01.2024 and quash the same and consequently direct the 1st respondent to approve the Form VII dated 04.10.2023 submitted by the petitioner in respect of society bearing Registration No. 44 of 1967.

3.With the aforesaid liberty in favour of the petitioner, this miscellaneous petition is closed.”

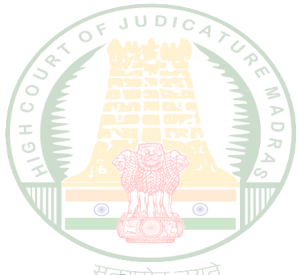
