2.Heard the learned Additional Advocate General assisted by the learned Additional Government Pleader for the petitioners and the learned counsel for the respondent in both petitions.

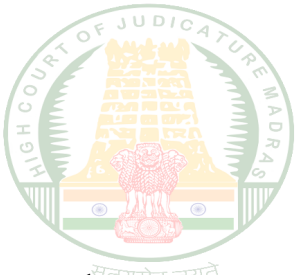
