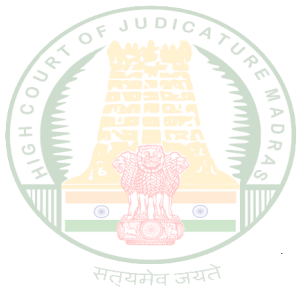
ORDER

The petitioner seeks to quash the final report in S.T.C.No.867 of 2025, dated 08.02.2025, on the file of the Judicial Magistrate, Radhapuram, Tirunelveli District, which was filed for the offence under Sections 296(b), 115(2) and 351(2) of BNS, 2023.

2. The allegation in the final report is that due to prior enmity, the petitioner abused the defacto complainant in filthy language, attacked and threatened him with dire consequences and thus, committed the aforesaid offences.

3. Admittedly, the parties have now entered into a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo dated 10.09.2025 and the scanned copy of the compromise memo reads as follows:

JOINT COMPROMISE MEMO

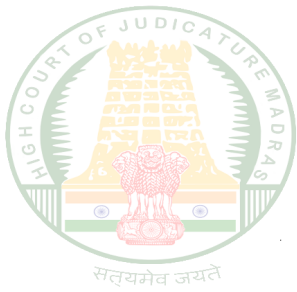
1. It is respectfully submitted that the Petitioner had filed the above Criminal Original Petition in Crl.O.P. (MD) No. 14494 of 2025 to quash the Charge Sheet in S.T.C. No. 867 of 2025 on the file of the Judicial Magistrate, Radhapuram, Tirunelveli District and pass orders.

2. The case of the prosecution is as follows: The Petitioner states that the 1st Respondent Police had registered a case against the Petitioner in Crime No. 37 of 2025 for the alleged offence U/Sec: 296(b), 115(2) and 351 (2) of BNS based on the complaint lodged by

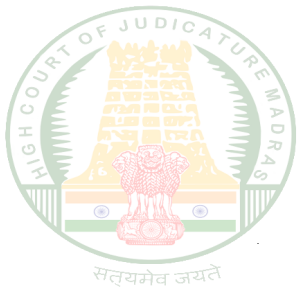
the 2nd Respondent herein. The 2nd Respondent/ De-facto complainant alleged in his complaint that on 16.01.2025 at about 7.30 P.M. the 2nd Respondent/Defacto Complainant went to Theatre Street, Vinayaga Purotta Staal opposite to Vavin Grand Mother's house for the purpose to saw his friend Vavin he was not come to work on that day. Thereafter, the 2nd Respondent/Defacto Complainant told his friend and telling to tomorrow come to the work for place of the Kuththanpatti. Thereafter, the Defacto Complainant turned a bike at that time the Petitioner interfering questioned the Defacto Complainant Who Are You? Why you are come in this Place? and attacked the Defacto Complainant and threatened him. Hence, the 2nd Respondent/Defacto Complainant admitted in the Government Hospital, Radhapuram. Hence, the complaint was lodged and the FIR was registered in Crime No. 37 of 2025 for the alleged offence U/Sec. 296(b), 115(2) and 351 (2) of BNS and the 1st Respondent had filed Charge Sheet in S.T.C. No. 867 of 2025 on the file of the Judicial Magistrate, Radhapuram, Tirunelveli District.

3. It is respectfully submitted that the Petitioner is innocent and they have not committed any offence as alleged in the FIR. However, before Charge Sheet filed by the 1st Respondent the Petitioner and 2nd Respondent were compromised and the elder members have intervened the matter and compromised the issue amicably. In view of the compromise arose between the petitioner and the 2nd Respondent/ De-facto complainant, he is not willing to proceed further with the criminal case against the petitioner. To that effect the present Compromise Memo has been filed.

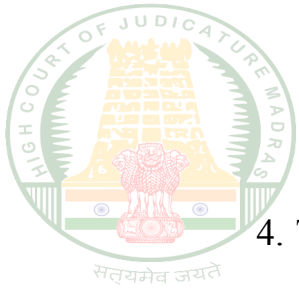

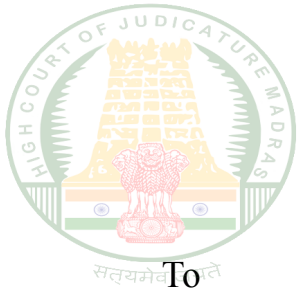

Accordingly, the impugned final report in S.T.C.No.867 of 2025, dated 08.02.2025, on the file of the Judicial Magistrate, Radhapuram, Tirunelveli District is quashed and the Criminal Original Petition stands allowed.
