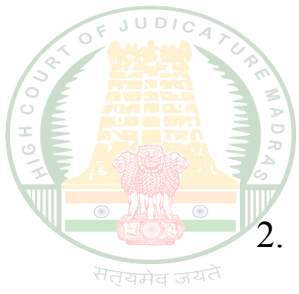

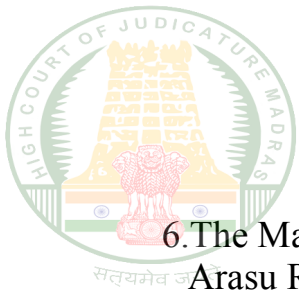
2. Recording the same, the writ petition is dismissed as withdrawn. No costs. Consequently, the connected miscellaneous petitions are closed.
