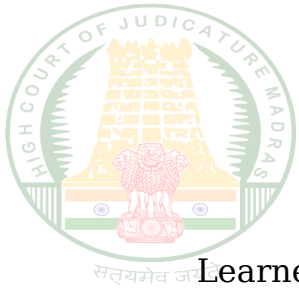

consequently for a direction, directing the respondents 1 & 2 to appoint the petitioner in the post of Special Teacher (Sewing) under MBC (Women) (PSTM) category on the basis of the total marks secured by the petitioner in the vacancies which are not filled for want of candidates in S.No.198, S.No.219 to 221 in School Education Department or in S.No.16, S.No.17 in Social Defence Department within the time period stipulated by this Court.
