4. The contemnors are directed to take steps to pay the arrears amount within a reasonable time.

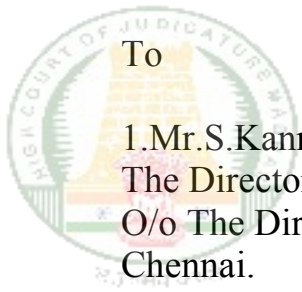
5. With the above direction, this Contempt Petition is closed. The personal appearance of the contemnors is dispensed with. Sub Application is closed.
