ORDER

The Criminal Revision is directed against the order passed in Crl.M.P.No.10384 of 2023, dated 17.07.2023 on the file of the Judicial Magistrate Court, Paramakudi, dismissing the petition filed under Sections 457 r/w 451 of Cr.P.C.

2. It is evident from the records that the respondent police seized the vehicle bearing Reg.No.TN-65-BY-4726 (TVS Radeon) in connection with the case in Crime No.110 of 2023 for the offences under Sections 4(1)(a) of TNP Act.
