## **ORDER**

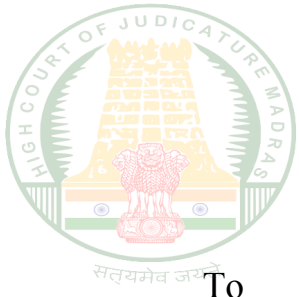
The petitioners seek for quashing of the impugned F.I.R in Crime No.362 of 2025, on the file of the 1<sup>st</sup> Respondent.
