The petitioners have sought for quashing of the impugned final report in S.T.C.No.398 of 2024 on the file of the District Munsif Cum Judicial Magistrate, Kariapatti, Virudhunagar District, for the offences under Sections 294(b), 323, 355 and 506(i) I.P.C and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.

2. The allegation against the petitioners is that due to wordy quarrel between the parties, the petitioners had abused the defacto complainant in filthy language, attacked her and also threatened her with dire consequences.

3. The learned counsel for the petitioners and the learned counsel for the defacto complainant / the second respondent would submit that the parties have now entered into a compromise on the advice of the elders and well-wishers and both the parties have agreed that the impugned final report may be quashed.

4. The parties have also filed a joint compromise memo dated Nil August 2025. The scanned copy of the compromise memo reads as follows:

**JOINT MEMO FILED BY THE PETITIONERS/ ACCUSED AND
THE 2ND RESPONDENT/ DEFACTO COMPLAINANT**

1. The Petitioners respectfully submit that they have filed this Criminal Original Petition praying this Hon'ble Court to quash the proceedings in C.C.No.398 of 2025 on the file of the Learned District Munsif Cum Judicial Magistrate, Kariapatti, Virudhunagar District.

2. The Petitioners respectfully submits that the gist and kernel and matrix of the complaint of the 2nd Respondent/ Defacto Complainant would reveal that it is reportedly alleged by the 2nd Respondent / Defacto complainant that the defacto complainant is running a Broiler Shop. The 1st Petitioner is running the Tea shop near Mustakurichi Bus Stop, Kariyapatti Taluk. The defacto complainant running a Broiler Shop, it is backside of the 1st Petitioner shop. The saw firewood was in front of the 1st Petitioner's shop, due to previous dispute between the Petitioners and the defacto complainant regarding to remove the firewood from the site. On 29.06.2022 at about 06.50 a.m., the defacto complainant had thrown the firewood in front of the 1st Petitioner's shop. When questioned the same of the 1st Petitioner, the defacto complainant stated that if you are stocking the firewood, if the snake entered in the firewood, the defacto complainant to beat the snake and she disposed the firewood. In the meantime, the 1st Petitioner, his wife, his daughter abused filthy language and threatened the defacto complainant. Due to altercation between the Petitioners and defacto complainant and others, the Petitioners attacked the defacto complainant with hands Thereafter, the Petitioners attacked and threatened the defacto complainant abused filthy language caused simple injury

with dire consequences. The defacto complainant admitted the Government Hospital, Kariyapatti for taking treatment and also she admitted the Government Hospital, Virudhunagar for further treatment. On the basis of the complaint, the 1st Respondent Police registered a case in Cr.No.156 of 2022 against the Petitioners.

3. The Petitioners respectfully submits that due to previous motive between the Petitioners and the defacto complainant. At the time of occurrence, the defacto complainant and her husband and her relatives namely Kalpana, Yogeswari @ Maheswari attacked and threatened the Petitioners abused filthy language with dire consequences caused simple injuries. The Petitioners admitted the Government Hospital, Kariyapatti. Thereafter the Petitioners given the complaint before the Respondent Police, on the basis of the complaint, the Respondent Police registered a case in Cr.No.157 of 2022 for the offence under Sections 294(b), 323, 447, 506(i) of I.P.C. against the defacto complainant and 2 others. Due to wreck vengeance for which, the defacto complainant lodged a false counter case in Cr.No.156 of 2022 before the 1st Respondent Police against the Petitioners. They are no way connected in the alleged occurrence.

4. The Petitioners respectfully submits that the defacto complainant lodged the complaint against this Petitioners before the 1st Respondent Police and the same was registered a case in Crime No.156 of 2022 dated 30.06.2022 for the alleged offence under Sections 147, 294(b), 323, 354, 355, 506(i) of I.P.C. and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002. filed the charge sheet before the Learned Judicial Magistrate No.II, Virudhunagar for the offence under Sections 294(b), 323, 355, 506(i) of I.P.C. and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002 and the same was transferred to the Learned District Munsif Cum Judicial Magistrate, Kariapatti, Virudhunagar District in turn the same was numbered as C.C.No.398 of 2025. The 1st Respondent Police filed the charge sheet before the Learned Judicial Magistrate No.II, Virudhunagar for the offence under Sections 294(b), 323, 355, of I.P.C. and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002 against the 1st Petitioner and punishable under Sections 294(b), 323, of I.P.C. and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002 against the 2nd Petitioner and also punishable under Sections 294(b), 323, 506(i) of I.P.C. and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002 against the 3rd Petitioner. Totally, there are 5 Accused in this case and the Petitioners have been arrayed as Accused No.1, 4 & 5. The Accused No.3 is deleted the above said case. The 2nd Respondent / Defacto complainant has signed the compromise memo on him without any influence or coercion and the F.I.R. in Crime No.156 of 2022 dated 30.06.2022 pending on the file of the 1st Respondent Police in connection with C.C.No.398 of 2025 have to quash in view of the same. The 2nd Respondent is giving no objection to withdraw the prosecution against the Petitioners in C.C.No.398 of 2025 on the file of the Learned District Munsif Cum Judicial Magistrate, Kariapatti, Virudhunagar District.

Hence, it is prayed that this Hon'ble Court may be pleased to record the compromise Memo and quash the charge sheet in C.C.No.398 of 2025 on the file of the Learned District Munsif Cum Judicial Magistrate, Kariapatti, Virudhunagar District and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render Justice.
