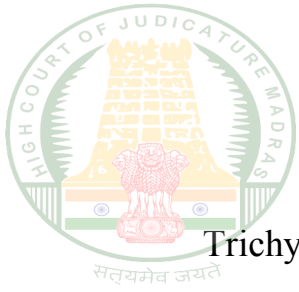
ORDER

WEB COPY This petition has been filed by the petitioner to direct the second respondent to complete the investigation and file the final report in Crime No. 185 of 2024 dated 07.05.2024.

2. According to the petitioner, he is the defacto complainant in this case and based on his complaint, F.I.R in Crime No.185 of 2024 has been registered for the offences under Sections 147, 294(b), 323, 324 506(2) of IPC and Section 4 of TN Prohibition of Harassment of Women Act, 2002. Thereafter, no proper investigation has been conducted and so far, not filed any final report. Hence, he has filed this petition.
