The petitioners seek to quash the final report in C.C.No.725 of 2024 on the file of the learned Judicial Magistrate No.III, Tirunelveli, which was filed for the offences under Section 294(b), 324, 506(2) and 120B of IPC.

2. The allegation in the final report is that the first accused conspired with the other accused and abused the defacto complainant in filthy language and attacked him with an iron rod and threatened him with dire consequences.

3. Admittedly, the petitioners and the second respondent are residing in the same Village and they have now entered into a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo and the scanned copy of the compromise memo reads as follows:

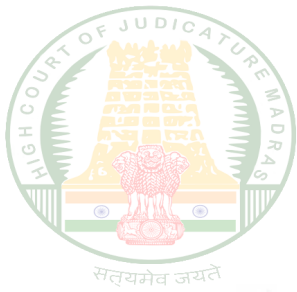

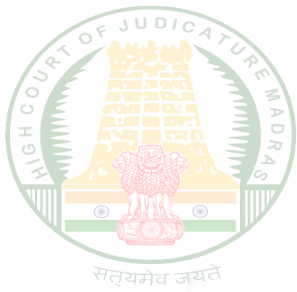
JOINT COMPROMISE MEMO

1. It is submitted that the Petitioners herein has filed above said quash petition to quash the charge sheet in C.C.No.725 of 2024 on the file of the Judicial Magistrate No.III, Tirunelveli in connection in Crime No.361 of 2023 registered by the 1st Respondent police for the alleged offences under sections 120(B), 294(b), 324, & 506(ii) of IPC.

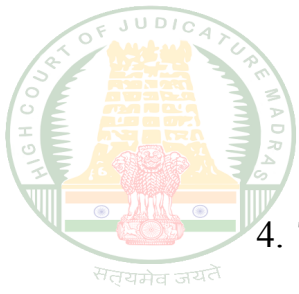

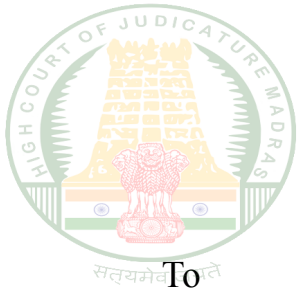
