To relax the condition imposed in Crl.O.P.(MD). No. 11231 of 2025 dated 28.07.2025.

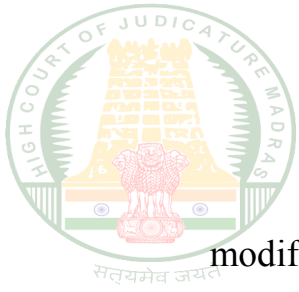
ORDER : The Court Made the following order :-
