There shall be no order as to costs. Consequently, connected Miscellaneous Petition stands closed.

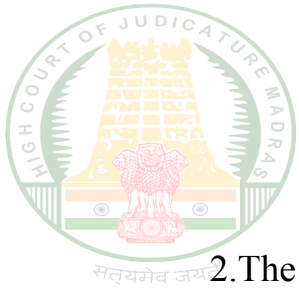
