ORDER

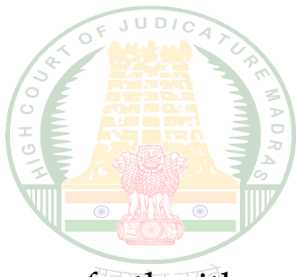
This petition is filed to condone the delay of 333 days in preferring the above Writ Appeal.
