2. Recording the above submission, this writ petition is closed. No costs. Consequently, the connected miscellaneous petition is also closed.

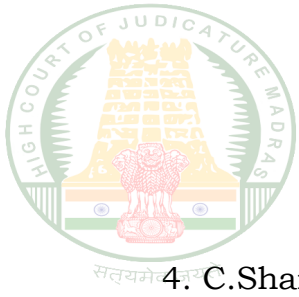
