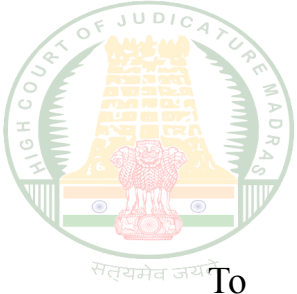
5. However, there is a direction to the District Collector, Sivagangai District to dispose the stay petition within a period of four (4) weeks from today, after hearing the petitioner.
