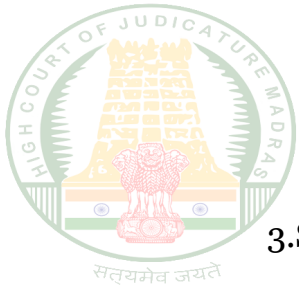

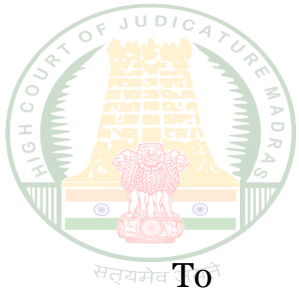
5.Petition is disposed of. There shall be no order as to costs. Consequently, interim application stands closed.
