through proceedings in L.Dis. No.16345/PNHIS-1/2023 dated 06.02.2025 within the time stipulated by this Court.

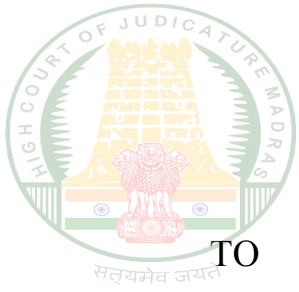
