The first respondent on receipt of such proposal, shall pass appropriate orders on the representation of the petitioner dated 30.06.2025 within a period of two weeks thereafter.

4. With the above direction, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition stands closed.
