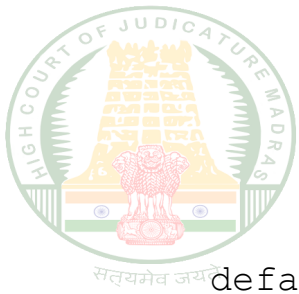

2.The learned counsel appearing for the petitioner submitted that the petitioner is the



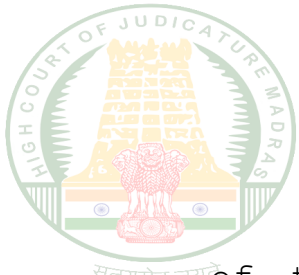

Hence, he seeks to cancel the anticipatory bail granted to the second respondent.

Side) appearing for the respondent-Police submitted that based on the complaint given by the petitioner's wife, the respondent Police conducted enquiry in current Paper No.G3/E-11441795/2062/2025 and closed the same, wherein it is clearly stated that there is no such event at all.
