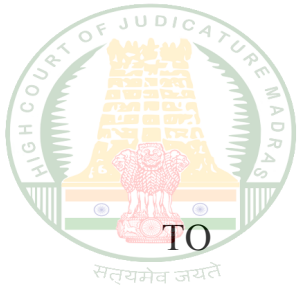
2. The learned counsel for the petitioner submitted that the petitioner has been complying with the conditions imposed by this Court and he prays for relaxation of the said condition.
