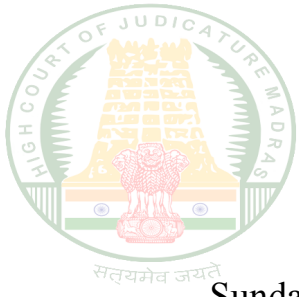

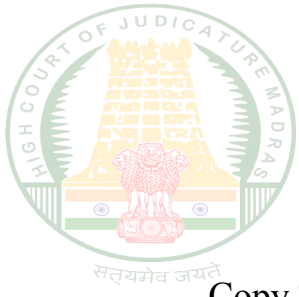
ADVANCE ORDER
