2.The learned Special Government Pleader opposes the withdrawal of the writ petition and wanted this Court to give a decision on merits.

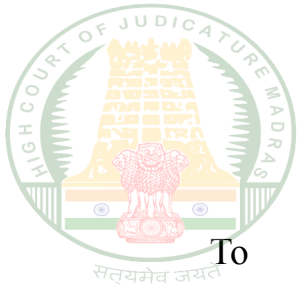
