To relax the condition imposed in Crl.O.P.(MD)No. 12241 of 2025 dated 23.07.2025.

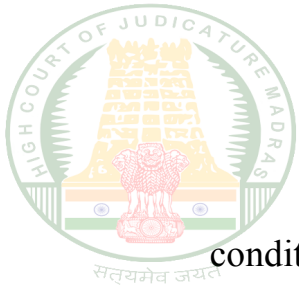
ORDER : The Court Made the following order :-
