2. The learned counsel for the petitioner would submit that, in similar circumstances, this Court had permitted the conduct of *Aadal Paadal* programmes subject to certain conditions, and therefore, the impugned order rejecting the permission sought by the petitioner is liable to be set aside.

The learned Additional Public Prosecutor, on instructions, would submit that the respondents will consider the petitioner's request in accordance with the circular issued by the Director General of Police, Tamil Nadu, Chennai, in Rc.007301/Genl I (I)/2019, dated 09.04.2019, during the course of today (i.e., 10.09.2025).
