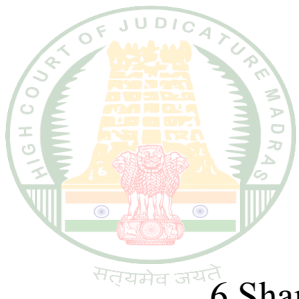

ORDER

Heard the learned counsel appearing for the writ petitioner and the learned Government Advocate appearing for the respondents 1 to 4.

2.The prayer in the writ petition is that the authorities should restrain the private respondents from cutting the standing trees in the

petition mentioned land. It is confirmed by the official respondents that the petition mentioned land is a patta land. It appears that there is a dispute between the petitioner on the one hand and the private respondents on the other. The petitioner appears to have lodged a complaint before the first respondent commission. It is for the petitioner to work out his rights in the manner known to law. Filing a writ petition is not appropriate.

3.Granted liberty to the writ petitioner to workout his rights before the jurisdictional civil Court or elsewhere, this Writ Petition is disposed of. No costs.
