2.The petitioner contends that there is a mistake in respect of the petition mentioned survey number in the revenue record. Even according to the petitioner, the mistake crept in during UDR. It is only the fourth respondent who is the authority competent to rectify such UDR errors. The petitioner is permitted to submit an appropriate petition before the

fourth respondent. It is well settled that for correcting UDR errors, there is no limitation. As and when such a petition is filed, it shall be taken on file and disposed of on merits and in accordance with law after issuing notice to the interested persons within a period of four months thereafter. I make it clear that I have not gone into the merits of the matter.

3.This Writ Petition is disposed of accordingly. No costs.
