ORDER

This writ petition has been filed for a writ of Mandamus to direct the respondents to settle the interest at the rate of 6% per annum for the belated payment of petitioner's husband's service benefits including Gratuity, Provident Fund, Old Leave Salary and Current Leave Salary from the date of petitioner's husband's end of service to till the date on which the said benefits were settled to him.

2. Considering the admitted fact that there has been a delay in payment, the petitioner's husband is entitled to statutory interest as provided under law.

3. In view of the same, the writ petition stands disposed of. The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner's husband from the date of his entitlement till the date of his payment, within a period of
