3. In view of the same, the writ petition stands disposed of. The

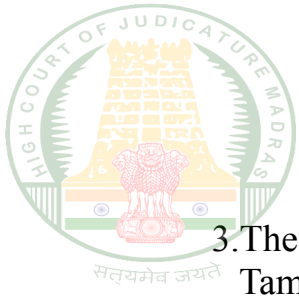
