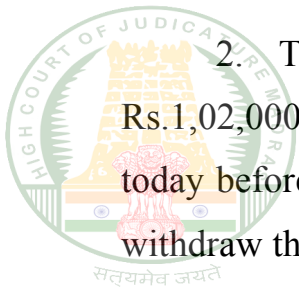

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant Mr.N.Shyllappakalyan and the counsel for the first respondent Mr.N.Chinnanallan are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

**AWARD**

Both the parties and their respective counsels are present and they arrived at an amicable settlement for a sum of Rs.1,02,000/- [Rupees One Lakh Two Thousand] as full quit.



2. The appellant is directed to deposit the entire settled amount of Rs.1,02,000/- [Rupees One Lakh Two Thousand], within a period of two [2] weeks today before the Tribunal. On such deposit, the claimant/ first respondent is permitted to withdraw the said amount, on filing proper petition before the Tribunal.
