By submitting that other persons whose names are listed in the relevant Town Survey Land Register are siblings of the petitioner, learned Special Government Pleader states that notice would be issued to them before acting on the petitioner's application.

3. In view of the submissions, without making any observations on the merits, this Writ Petition is disposed of by directing the first
