To relax the condition imposed in Crl.O.P.(MD). No. 12907 of 2025 dated 05.08.2025.

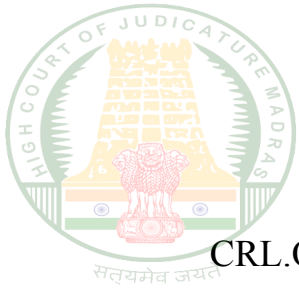
ORDER : The Court Made the following order :-
