The order passed by the Co-operative Tribunal is to be challenged by way of Civil Revision Petition and not by way of Writ Petition.

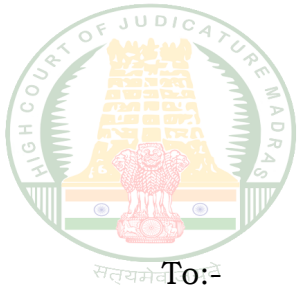
2.The petitioner has filed this Writ Petition as early as in the year 2017.

Consequently, connected Writ Miscellaneous Petition stands closed.
