2.Today(28.01.2025), when this writ petition is taken up for hearing, the learned Special Government Pleader appearing for the respondents by referring to the proceedings of the Block Development Officer, Mudhukulathur dated 22.01.2021 submits that they have taken initiative to pay the arrears of salary and it would be settled to the petitioner positively by today.

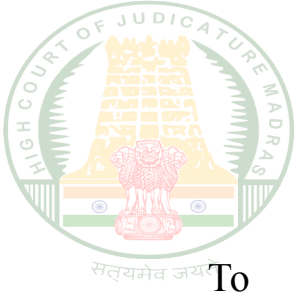

4.Recording the submission made by the learned Special Government Pleader and the proceedings of the Block Development Officer, Mudhukulathur dated 22.01.2021, this writ petition is closed, with a direction to the respondents to pay the arrears of salary with interest at the rate of 6% per annum, within a period of one week from the date of receipt of a copy of this order.
