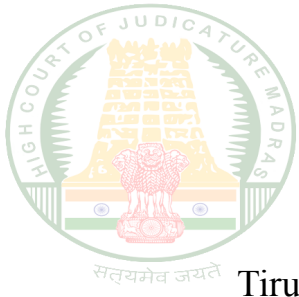

2. Since Mr.Sarangan would submit that there is no limitation that is provided for filing a petition before SLSC, the petitioner may well avail of this remedy.

3. Faced with this position, learned counsel for petitioner would also agree that, that would be an appropriate course of action and that he would approach the SLSC forthwith.

4. This writ petition is disposed with liberty as aforesaid. No costs. Connected miscellaneous petition is closed.
