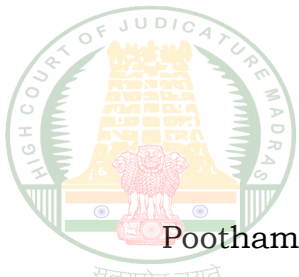

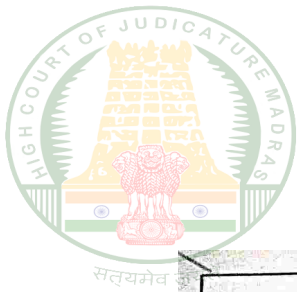

ORDER

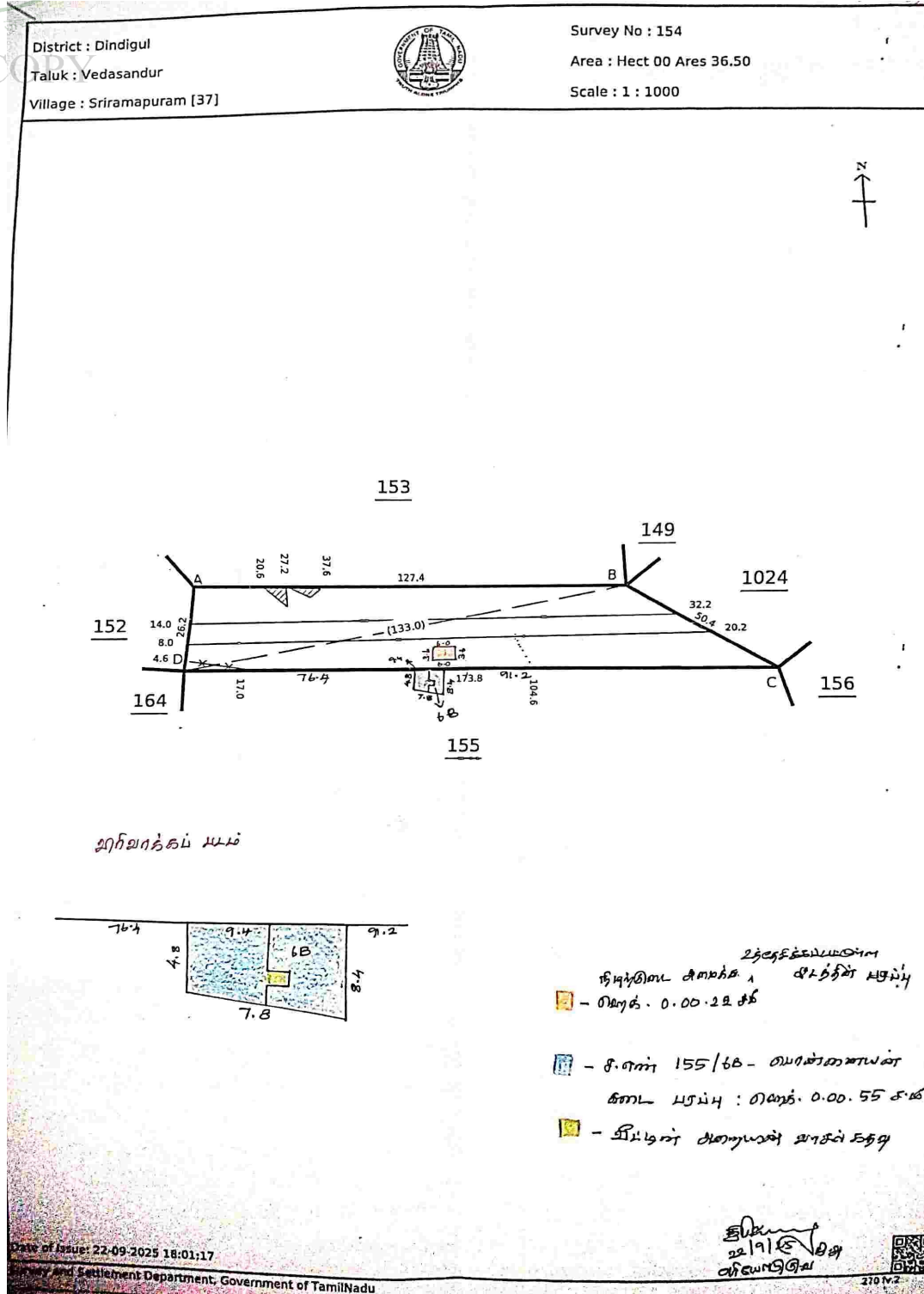

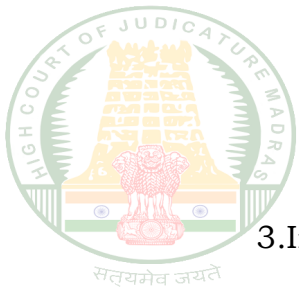
