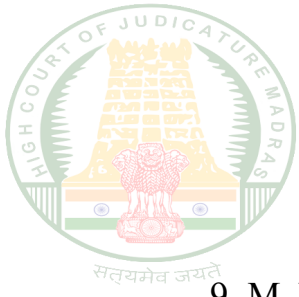

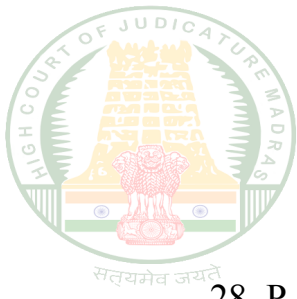

For Respondents : No appearance

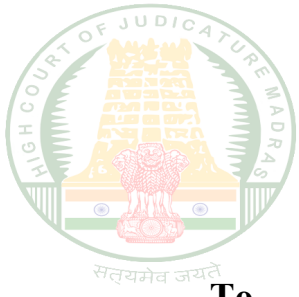
ORDER
