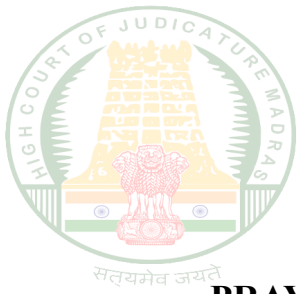

ORDER

By asserting that the petitioner constructed a small house on the land in survey No.267/2 and has resided there for more than 50 years, the petitioner applied for a house site patta. Since the fourth and fifth respondents did not take any action thereon, the present petition has been filed.

2. Learned Government Advocate accepts notice for all the respondents. On instructions, he submits that the petitioner's request would be considered and disposed of within twelve weeks.
