To relax the condition imposed in Crl.O.P.(MD). No. 11934 of 2025 dated 14.08.2025.

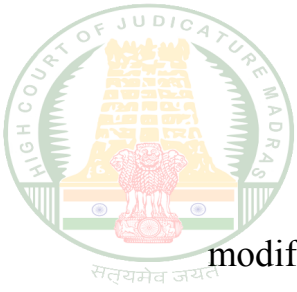
ORDER : The Court Made the following order :-
