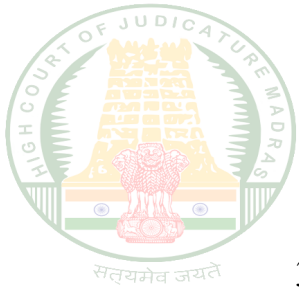

COMMON ORDER

The Criminal Miscellaneous Petition has been filed seeking orders to condone the delay of 1520 days in challenging the order made in M.C.No.16 of 2014 dated 05.07.2018 on the file of the District Munsif cum Judicial Magistrate, Cheranmahadevi.

When the matter is taken up for hearing today, the learned counsel appearing for the first respondent would submit that the petitioner has filed similar petition to condone the delay of 1835 days in filing the revision challenging the very same MC order in Cr.M.P.No.14941 of 2023 before the Principal Sessions Court, Tirunelveli and after enquiry, the said petition came to be dismissed on 03.01.2025.
