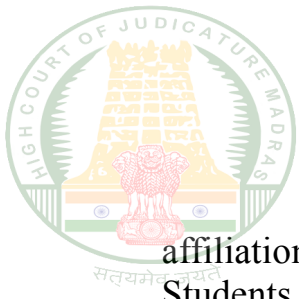

No. NCTE/SRC/SRCAPP1908/M.Ed./467th Mtg./TN/2025/151704 151707 dated 31.07.2025 and quash the same in so far as commencement of 1 Unit of 50 Students of M.Ed course from the Academic Year 2026-2027 and consequently direct the respondents 1 and 2 to grant modified recognition order for conducting 1 Unit of 50 Students of M.Ed course from the present academic session 2025-26 in place of the academic session 2026-27, already granted by the Respondent No.1 and direct the 3rd respondent University to grant
