second respondent vide his proceedings No.Nil dated 28.08.2025 and quash the same as illegal and biased one and consequently directing the respondents 2 and 3 to follow uniformity in eviction process including the petitioner and against the respondents 4 to 8 herein, in respect of the encroachment in the channel from Pappankulam to Chethupatti Periyakulam comprised in survey Nos.457, 465, 466, 470, 488 and 490 and other survey numbers situated at Muthalvarpatti Village, Marungapuri Taluk, Trichy District.

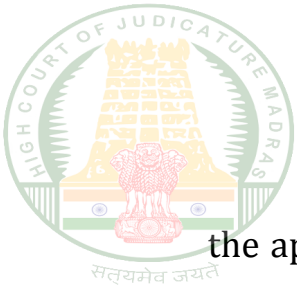

ORDER

Heard both sides.

2. The petitioner challenges the order passed by the second respondent under Section 6 of the Tamil Nadu Land Encroachment Act, 1905. The petitioner had encroached on the channel. He has engaged in cultivation. The petitioner's counsel states that he filed an appeal under Section 10 of the Act and that the impugned proceedings can be directed to be kept in abeyance till the disposal of



the appeal. When the petitioner resorted to avail the appeal remedy, his remedy is there. If the petitioner has even a semblance of right, he would have definitely been granted some interim protection. The petitioner does not have any right at all. We do not find any ground to interfere. This writ petition stands dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
