ORDER

The petitioner seeks quashing of the FIR in Crime No.637 of 2025 on the file of the first respondent, for the alleged offences under 296(b), 115(2), 351(2), 326(g), 62 of BNS Act, 2023 and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002.

2. The defacto complainant is the wife of the petitioner. The allegation in the FIR is that on account of prior enmity, the petitioner came to the shop run by the defacto complainant, abused her in filthy language and attacked her besides pouring petrol on her.

3. The learned counsel for the defacto complainant would submit that the parties have now entered into a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo and the scanned copy of the compromise memo reads as follows:

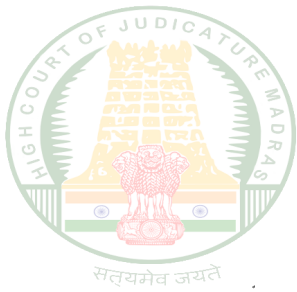

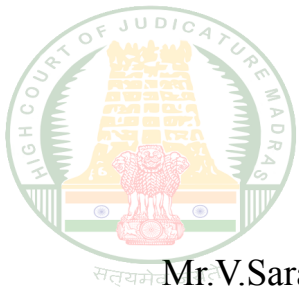
