Upon perusing the documents and case records of the above
P.R.C.No.34 of 2021 transmitted to this Court and hearing the arguments
of *Mr.S.Ravi, learned Additional Public Prosecutor*, on behalf of the
State, this Court passed the following

ORDER

Prelude:

*“This dedicated bench is for implementing the pilot project to
identify and dispose of criminal cases involving offences punishable with
imprisonment up to 3 years pending at trial, appeal or revision stage for*

more than 3 years and also offences like Section like Section 506(ii) of IPC and others, which may carry a punishment of more than 3 years in the State of Tamil Nadu with reference to the 14 Districts coming under the Madurai Bench of Madras High Court.”

2.This Dedicated Bench has taken the **P.R.C.No.34 of 2021** on the file of the **Judicial Magistrate Court, Thirumangalam Taluk, Madurai** as ***Suo motu* Special Tr.Case.(MD) No.12270 of 2025** in **Suo Motu W.P. (CrI.).(MD).No.1014 of 2025**, upon proper scrutiny and considering its suitability that it is a fit case warranting the exercise of power under Article 226 of Constitution of India to quash the said C.C., which is pending for more than **four** years without any progress.

3. Brief facts of the prosecution case in P.R.C.No.34 of 2021:

According to the prosecution, on 05.10.2014, at about 07.00 p.m, when the complainant, her children and her mother-in-law were watching T.V, the accused are said to have trespassed in to the house of the complainant and robbed gold chains from the neck of the complainant and her mother-in-law at knife point. Therefore, a case was registered in **Crime No.244 of 2014 for the offences punishable under Section 397 of IPC**. On investigation, final report has been filed

and the same was taken cognizance in **P.R.C.No.34 of 2021** and the same is pending without trial for more than **four years**.

4.When the matter is taken up for hearing Mr.Ravi, the learned Additional Public Prosecutor, on instructions, would submit that Non Bailable Warrant was issued against the accused and the same was executed and all the accused are produced before the learned **Judicial Magistrate, Thirumangalam Taluk, Madurai District**.

5.The learned **Judicial Magistrate, Thirumangalam Taluk, Madurai District**, is hereby directed to complete the trial in **P.R.C.No.34 of 2021** within a period of 2 months from the date of receipt of a copy of this order.

6.With the above said directions, this suo motu transfer petition stands closed.
