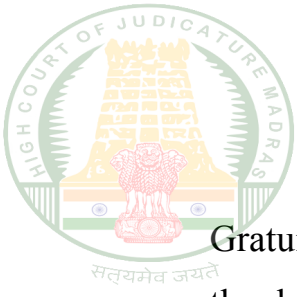

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.
