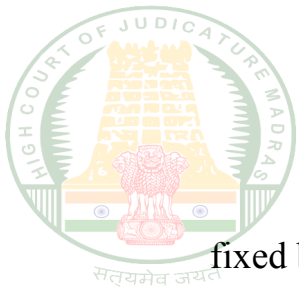

**PRAYER:** Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the impugned order passed by the third respondent *vide* his proceedings in File No.2025/0103/14/368840 dated 22.07.2025 and quash the same as illegal and ultra-vires and consequently, direct the respondents 2 and 3 to consider the petitioner's online application dated 22.07.2025 for mutation of Patta in respect of S.F. Nos.280/6A and 280/6B, Kathaparai Village, to an extent of 0.20 Ares (20 cents) in favour of the petitioner within a time frame as may be

fixed by this Court.

### **ORDER**

By asserting title over 20 cents of land in survey Nos.280/6A and 280/6B, the petitioner had applied for a patta. The said request was rejected by the order impugned herein.

2. Learned counsel for the petitioner invited my attention to the order and pointed out that it is a non-speaking order.

3. Learned Government Advocate accepts notice on behalf of the respondents. He submits that the matter may be remanded for reconsideration.

4. On perusal of the impugned order, such order is self-evidently unreasoned. Consequently, it is unsustainable and is hereby set aside. As

a corollary, the matter is remanded to the Tahsildar/second respondent for reconsideration. After providing a reasonable opportunity to the petitioner and any other persons interested in the relevant property, a speaking order shall be issued within a period of twelve (12) weeks from the date of receipt of a copy of this order.

5. Accordingly, this Writ Petition is allowed. No costs.

Consequently, connected miscellaneous petition is closed.
