To relax the condition imposed in Crl.O.P.(MD). No. 12028 of 2025 dated 31.07.2025.

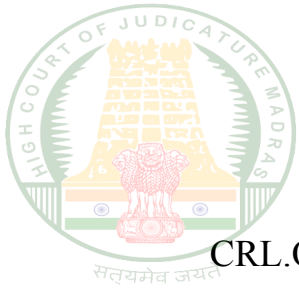
ORDER : The Court Made the following order :-
