Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus calling for the entire records pertaining for the order issued by the 3rd respondent Na.Ka.No.21/2024 dated 06.04.2024 and quash the same and direct the 1st respondent to Ratify the permission granted by the 3rd respondent for M.Phil degree of petitioner and consequentially direct the respondents continue to award incentive increment for M.Phil decree with effect from the date of passing of said decree to the petitioner.
