petitioner would be provided the certified copies of the specific documents requested for by him.

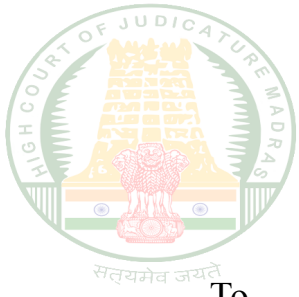
4. Accordingly, this Writ Petition is disposed of with the following directions:
