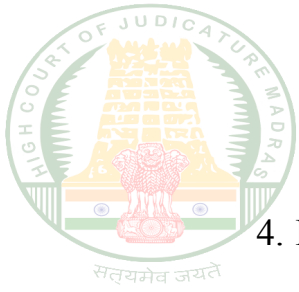

This Writ Petition is filed for Mandamus to direct the second respondent to consider the petitioner's representation dated 31.05.2025.

2.
